RE: Coronavirus update and potential school closure due to the spread of coronavirus

Dear Parent or Carer,

As the coronavirus (COVID-19) continues to spread and the number of confirmed cases in the UK increases, we are making plans to cover all eventualities.

We take the health and safety of our pupils and staff very seriously, and while there is currently no immediate cause for concern at our school, we will keep you updated with any developments, including whether we will need to close.

Current guidance from the Department for Education (DfE) and Public Health England (PHE) remains that schools stay open; however, it is possible that this advice may change as the rates of infection continue to rise. We have not been provided with any specific advice yet regarding children with complex medical needs. However the updated guidance from the government briefing yesterday strongly advised social distancing for those individuals with underlying health conditions. Therefore if you feel your child falls into this category and wish to keep them at home to self-isolate, we will authorize their absence.

Additionally the guidance states that those in a household where someone has a continuous cough and/ or temperature should now isolate themselves for 14 days.

In the event that we do close the school, you will be informed via text message or email and advised on how long we expect the closure to last. Please check that you have provided us with your most up-to-date contact details to ensure you receive any notification regarding a closure. If you need to provide us with new details, please contact the school office on 01642 66 41 40.
